Ms. Ozbolt:

For drinking water, the applicant states (copied and pasted directly from the submittal):

Water: Water will be provided from an on-site well. This will be provided onsite by the applicant.

Based on the actual source of this water, the following are possible approaches for drinking water:

- 1. Campground is part of an existing public water system. If this proposed campground intends to use their own well, and the existing well is part of their own existing, approved public water system the applicant needs to provide the name of the existing water system, so DOH can check if the existing water system has available connections. If the existing water system does not have available connections, then the proposed campground would either have to develop their own water system (please see Comment 3, below) or conduct a Capacity Analysis of the existing system to see if the existing water system has available capacity.
- 2. Campground is connecting to an existing public water system. If this proposed campground intends to connect to an existing well that is part of an existing water system DOH would follow through the same as noted in Comment 1, above; and, also check whether the existing water system has a Duty to Serve, or is willing to serve, this campground.
- 3. No existing water system. If the cited well is a new well source and is not part of an existing public water system, the campground water system will be either a Group A or Group B public water system and will require well approval and water system approval:
  - For a "smaller" Group B: Kittitas County Health would be the reviewer.
  - For a "larger" Group B or Group A: DOH would be the reviewer.

These constitute the full extent of DOH Office of Drinking Water comments on the application.
