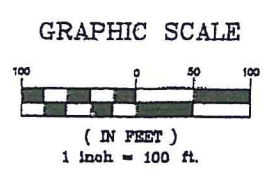
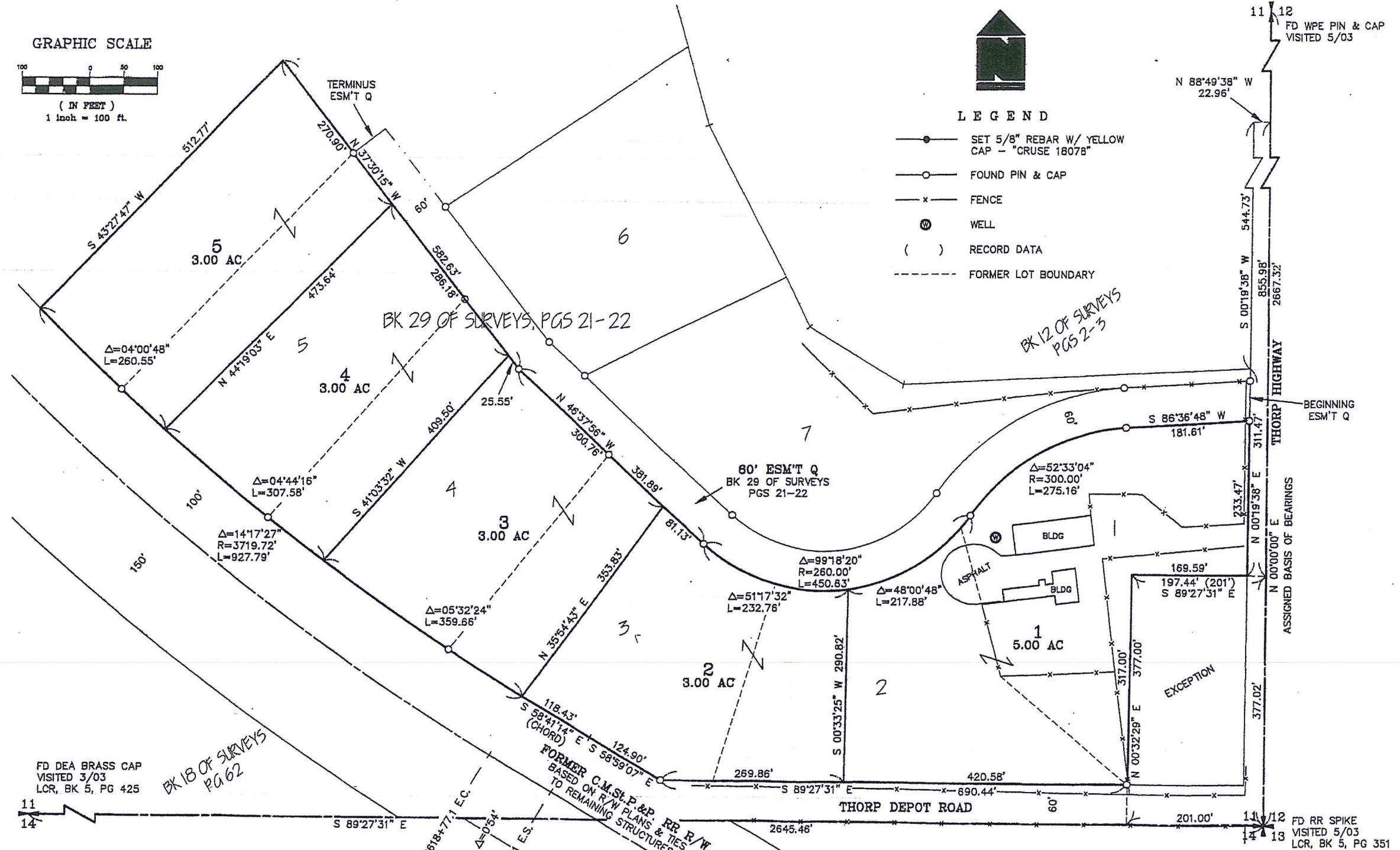


PART OF THE SE 1/4 OF SEC. 11, TOWNSHIP 18 NORTH, RANGE 17 EAST, W.M.

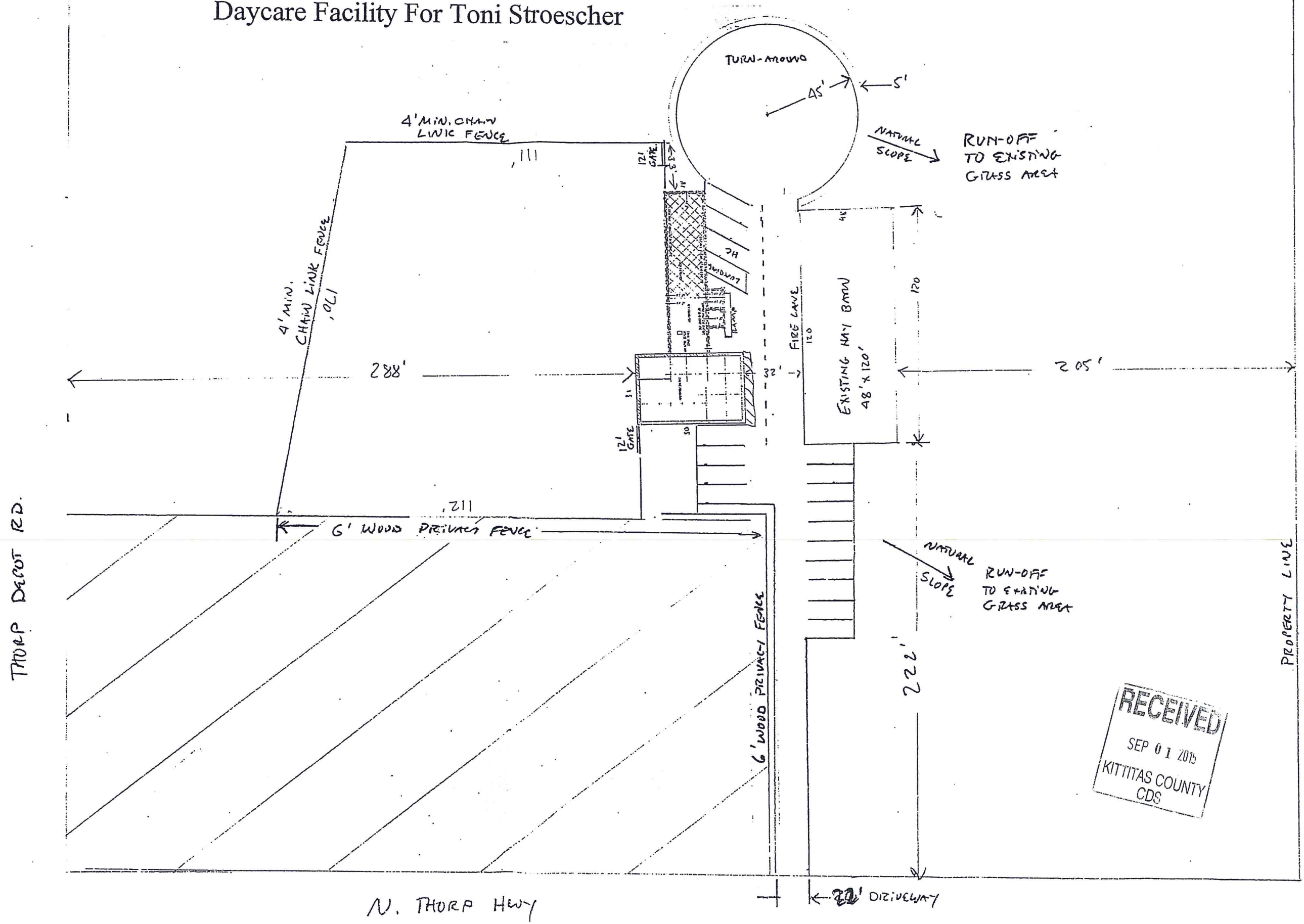
