Thank you for the opportunity to comment on the above listed Conditional Use Permit Application.

After review of the CUP application, I have the following comments:

- 1. An equipment shelter over 120 sq. ft. requires a building permit. If it is a pre-fab shelter it must be inspected and approved by Washington State Labor and Industries first. Please provide the following:
 - 1. Site plan
 - 2. Building and slab/concrete plans
 - 3. Engineering
- 2. A separate permit is required to construct a 150'-0" communication tower. Items required:
 - 1. Site plan
 - 2. Footing/foundation plan
 - 3. Engineering for footing and tower

A completed PSA is also required.

Building permit fees are based on the cubic footage of the concrete footing.

A generator and/or fuel tank (if any) is permitted through the Fire Marshal. You can submit for that at the same time as the building permit or it can be submitted separately.
