I've looked over the documents and I think I've had all my questions answered. In talking with Russell Mau, it seems that our numbers will fall short of what is required for a Group A well. I've also confirmed with WSDOT that our driveway will only need to be rerouted when our expansion constitutes a "change of use", e.g., visitor facilities or intern housing, and not for the early phases of our expansion which will involve improved veterinary and quarantine facilities.

An update to the current WFI form will need to be done showing the accurate numbers of regular non-residential users. The numbers in the project narrative indicate the system may need to be re-classified to a Group A system in which case they will need to work with DOH on that approval and upgrade prior to the addition of users.

These conditions should be mitigated for.
