






<u>Rural Working</u> <u>Land Use</u>



<u>Site Plan: Original WSDOT</u> <u>Requirements</u>




Washington State Department of Transportation:




Ecology Comments

Water System must be reclassified to Group A water system. Application must be made to the Department of Health.


Nitrate test must be performed.

Critical Areas Analysis

Critical Areas Analysis found a Type 9 stream, Bonneville Power Authority easements, and hazardous slopes within the property.

No proposed additions will fall within required hazardous slope buffers. The proposed addition of the parking lot falls within 15 foot Type 9 buffer. Wetland reconnaissance should verify existence, location, type, and extent of stream. Ecology can review during wetland reconnaissance.
