Chapter 14 of Kittitas County Code specifically exempts the State from our grading permit requirements providing oversight by a licensed professional engineer. KCC 12.01.030 contemplates a road building action being conducted by another governmental jurisdiction that supersedes County Code. It is my decision that DNR building roads on State land satisfies the exemption as contemplated by KCC 12.01.030. I am attaching both references in this email. Retain them for your project record. I am also providing copy to Ms. Lindsey Ozbolt (Planning Official) for reference to DNR's pending Conditional Use Permit. Please let me know if I can be of any further assistance in your Conditional Use Permit process with Kittitas County. Regards, Cook.
