Thank you for sending this consultation to the Yakama Nation. The project location is considered to be sacred and sensitive to the Yakama Nation and is in close proximity to historic resources. We therefore request appropriate considerations and evaluations take place to identify potential cultural resources. We do not concur with DAHP that it is low probability for containing cultural resources or that it does not warrant an appropriate survey. We are further concerned with the potential impacts to ground water and surface water where Yakama Nation and its partners have been working to maintain critical instream flows important to the aquatic life in the Upper Yakima Basin. We may need additional time to fully evaluate all of the associated components of this action and may revise our comments based on further information.
