Dear Ms. Bacon,

Thank you for the opportunity to comment on the CU-20-00005 Hidden Point application concerning the construction of a Guest Ranch on Emerick Road, east of Cle Elum ("the project"). The proposal states that development initially would include four bunkhouses, with potential future phases adding up to 20 additional bunkhouses (24 total), a pool, and a kitchen encompassing 34 acres. Washington Department of Fish and Wildlife (WDFW) has reviewed the application and supporting documents. Our comments are in regard to the project's impact on priority fish and wildlife habitats.

The project is in an area which is documented by multiple sources to be of high importance to wildlife. The proposed project area is within mapped Mule Deer and Elk winter areas as part of WDFW Priority Habitats and Species (PHS) database. In the statewide wildlife connectivity analysis, the area is mapped as potential migration areas for various wildlife including Mule Deer, Black Bear and Western Gray Squirrel. Further, there are a suite of non-game species that might be present on the property given potential habitats in the area including Pileated Woodpecker, Blackbacked Woodpecker, White-headed Woodpecker, Ring-necked Snake and Sharp-tailed Snake. Pileated Woodpecker, Black-backed Woodpecker, White-headed Woodpecker, and Sharp-tailed Snake are all candidate species for listing in the state. Ring-necked Snake is a priority species. These mapped potential occurrences of wildlife are reinforced by wildlife observations from neighboring residents in the area that they have shared with WDFW, particularly Mule Deer, Elk, Black Bear, Western Gray Squirrel, Pileated Woodpecker, Black-backed Woodpecker and White-headed Woodpecker. The SEPA application for this proposal does not include any of the above information, except a vague reference to Swauk Prairie under the question on migration route. Thus, WDFW requests that the SEPA checklist be revised to include the above information on Priority Habitats and Species under Section B.5 of the checklist.

Development in these priority habitat areas have a high potential to impact a species' use of the habitat, either through direct habitat removal (clearing) or indirect impacts through more intensive use of the property which could result in disturbance and displacement for the wildlife. These potential impacts on priority wildlife species and their habitats, are part of Kittitas County Critical Area Ordinance under Kittitas County Code Title 17A, Fish and Wildlife Habitat Conservation

Areas. To be able to properly assess the impact of this development on these priority species, WDFW requests a Critical Areas Report, specifically a wildlife species and habitat management plan be completed by a qualified professional before evaluating whether this conditional use could be approved or not. That critical areas report should address the priority species listed above, the habitats on the property, and any other known or documented wildlife on the property. The report should be conducted by a professional with a wildlife background ("qualified professional") and should outline if the proposal were to go forward, measures that the applicant can demonstrate on how to mitigate for the impacts to the priority species. As a technical expert in this critical area, WDFW requests that it be presented with a copy of the report and allowed to provide comments to Kittitas County on whether the measures outlined in the report are sufficient to mitigate the impact to species and habitats prior to considering approval for this Conditional Use permit.
