Dear Mr. Carlson and Ms. Bacon:

I write to you today to formally request an extension of the public comment period for the Conditional Use Permit Application CU-20-00005, Hidden Point. The current deadline is 5 pm on January 4, 2021. For the reasons set forth below, I request an extension through January 27, 2021 to allow receipt and meaningful review of the materials discussed below.

Notice of Application was provided on December 17, 2020 with a deadline to submit comments of 5 pm January 4, 2021. Since that time, I have inquired as to whether concerns and complaints regarding Hidden Point received before the CUP application was submitted (November 20, 2020) will be included in the CUP application file. I am personally aware of several complaints regarding Hidden Point prior to November 20, 2020. The complaints relate to code and zoning violations and community concerns about the Hidden Point project. These complaints and concerns from members of the community are highly relevant to the pending CUP application as they speak to the applicant's disregard for the character of the community. See KCC 17.60A.015 (CUP application review criteria).

Notwithstanding their relevance, the County states it will not be including these prior submissions in the CUP application file. A copy of this correspondence is attached hereto as Exhibit A. The County indicates that it will be seeking further clarification from its Prosecuting Attorney, but that such response may take up to two weeks, which falls *after* the deadline for public comment and supports an extension of the public comment period.

Community members were under the impression that complaints sent to the County prior to November 20, 2020 would be included in the review relating to the CUP application. It now appears that impression was incorrect. As a result, community members must now be informed that their prior complaints will not be reviewed as part of the CUP application and that they must re-submit all prior complaints, both of which require time and further support an extension of the comment period.

In addition to issues relating to prior submissions, I have made a public records request for documents relating to the Hidden Point parcels. Today I received notification that those records will not be provided until January 22, 2021, which is a month after the request was made and falls several weeks *after* the deadline to submit public comments. *But see* RCW 42.56.520 (requiring prompt disclosure). The content of those documents will inform my public comments and will also inform the decisionmaker's ultimate decision. My request and the County's response are attached hereto as Exhibit B.

Lastly, due to the pandemic and holiday season, community members and local and state organizations are likely to struggle to provide a meaningful response in the time presently allotted. Many state agencies are operating on a modified schedule due to the pandemic, which is further curtailed by holiday closures and prescheduled vacations. Additional time will help ensure that a meaningful response will be provided by state and local agencies as well as community members. While the requested extension is beyond the scope contemplated in KCC 15A.03.060(2)(f), the pandemic presents an exigent circumstance not contemplated by the drafters. The holiday season further compounds the effects of the pandemic and effectively reduces the comment period to a timeframe much shorter than required by KCC 15A.03.060(2)(f).

Without access to all communications relating to the Hidden Point project and without a reasonable time to provide meaningful response, neither the community nor the decisionmaker will be able to make an informed decision. Closing the comment period without all relevant documents will prevent proper analysis and result in an <u>uninformed decision</u>, which is contrary to the intent of the CUP process. *See generally* KCC 17.60A.

For the above reasons, I respectfully request that the comment period for CUP application CU-20-00005 Hidden Point be extended to January 27, 2021. This will allow time for meaningful responses from interested parties in light of the factors summarized above.

Good morning Theresa,

Community Development Services has no precedent of including code enforcement documents or pre application submittal comments in the record. As previously mentioned, they can always resubmit any documentation during the comment period and it will become part of the record. KCC 15A.03.060(2)(f) notes a comment period of no less than 14 days and no more than 30 days to be included in the notice of application. WAC 365-196-845(9) does allow for the County to accept comments any time before the decision, and in this case we are choosing to do this beginning from the application submittal date, to prevent any confusion with multiple submittals of the same comments.

We will not accept public comments that were submitted prior to the application submittal, as we have no system for filing and retaining these comments without an associated application. Such a policy is necessary to ensure we do not lose track of public comments. KCC Title 15A does not include any language requiring previous code enforcement action documents to be included in the record of land use applications.

The Planning Official has submitted a request for clarification from the Prosecuting Attorney's Office. Sometimes their responses can take a couple of weeks. Once we have heard back from their office, I will let you know. **EXHIBIT A**
