Phase 1: Build four (4) bunkhouses with a shared septic system

Phase 2: Potentially build up to 20 additional bunkhouses (phased in clusters of four) and a pool and kitchen. If these future phases happen, they would begin no sooner than 2022.

Possible future phases would create more clusters of bunkhouses as well as pool/kitchen. Bunkhouses are less than 400sf and are comprised of living space and bathroom (no kitchen).


