## **DETERMINATION OF NONSIGNIFICANCE**

File: CU-22-00003 Brethren Frontier School

**Description:** The project application proposes the use of the existing school building as well as

the addition of a multipurpose building for the use by the co-op school. The facilities would be mainly used on Thursday afternoons during the spring and fall for homeschool co-op classes and the Multipurpose building would be used for occasional sports and events for the co-op school. The subject parcel is zoned Commercial Agriculture with a Commercial Agriculture land use designation.

**Proponent:** Brethren Frontier School (landowner), Eric Leensvaart (agent)

**Location:** Parcel 13147 located at 4900 Manastash Rd, Ellensburg, WA. In the NW1/4 of Section 18,

Township 17N, Range 18E.

Lead Agency: Kittitas County Community Development Services
