Kittitas County Community Development Services (CDS) received your New Suncadia, Phase 1, Division 15 (LPF-18-00006) Final Long Plat submittal on September 19, 2018.   - 4. The additional R/W to be dedicated to Suncadia Trail should be labeled as "additional right of way herein dedicated."
  - 5. Sheet 4 includes a legend item "Found corner as noted". Please note what was found in the two locations containing this symbol.

## Assessor - (email attached):

No required changes

As stated above, review, signature, and approval of this plat must occur within 30 days of September 19, 2018. Therefore, this plat must be placed on the October 16, 2018 Agenda (the last Agenda board meeting within the 30 day window) for Board decision and signature. With that said, as the required information requires additional review by other departments prior to

BOCC signature, the requested information needs to be provided to CDS by October 9, 2018 unless you provide in writing agreement to an extension for BOCC signature on November 6, 2018, pursuant to RCW 58.17.140(2). This timeline provides adequate review time for all parties. Please work directly with Public Works regarding the road and utility infrastructure bonding requirement.

Once required information is ready please submit to CDS as one submittal packet. Once the requested information has been resubmitted, the various departments will review for consistency. All revised information needs to be submitted to Kittitas County CDS by end of business day October 9, 2018 for staff review and signature on the final mylars (this assumes all issues have been addressed adequately and required information has been provided).
