Hi Brianne and Steven,

I am writing to give you an update on your final plat application Suncadia Ph.3 Div. 14, LPF-18-00007. The agency review period ended yesterday resulting in several changes necessary before agency signature. I had hoped to schedule your application for Board signature on October 22nd. Unfortunately this meeting has been cancelled. This creates an issue with meeting the 30 day requirement in RCW 58.17.140(2). The good news is this will provide you a more comfortable time frame for the necessary corrections/submittal materials, but unfortunately CDS will need a letter or

email from you prior to the expiration date (October 27th) agreeing to an extension through October 31st (the next available Board meeting), or we have no choice but to return the application.
