Applicants,

Kittitas County Community Development Services (CDS) received your Palomino Fields Division 5 (LPF-19-00004) Final Long Plat submittal on September 9, 2019. Kittitas County staff have completed a third review of your final plat submittal. As provided below, staff has the following comments, requirements, and/or revisions for your application that need to be addressed prior to final approval and signature of the final plat mylars:

Community Development – Planning:

- No additional requirements

Public Works – Planning/ Survey Review (memo attached):

- Required: Please see attached memos for required changes and additional review fees. Please work with Kittitas County Public Works to resolve the issues outlined in the attached memo.

Environmental Health:

- Public Health has no further requirements.

Assessor:

- Assessor provided no comment

Kittitas County Public Works performed two previous reviews (April 23, 2019 and July 26, 2019) of the Final Plat application for Palomino Fields Division 5. Kittitas County Public Works have completed a third review of the materials you submitted on September 9, 2019 and again discovered necessary corrections and roadway concerns. Kittitas County Public Works will require additional fees (as outlined in the attached memo) for any further review of the Palomino Fields Division 5 final plat (LPF-19-00004). CDS is returning your application to allow for all requirements to be met pursuant to RCW 58.17.140. Once the final mylar is submitted to CDS, meeting all requirements, a new thirty day review window will begin and a date for anticipated BOCC signature will be provided. Please work directly with Public Works regarding their requirements if any questions arise.
