Good Morning,

I have scheduled signatures with the relevant agencies for the final plat application noted above. RCW 58.17.140(2) requires final plat approval within 30 days of submittal of the plat. Unfortunately the 30 day period ends on a Saturday (24th), and two days before I can schedule the final BOCC signature. According to the RCW I must return the plat to the applicant unless the applicant consents to an extension to the 30 day requirement in writing. My plan is to schedule BOCC signature for August 26th. If you can provide something in writing (an email will suffice) consenting to the extension until the 26th, we can proceed with obtaining all required signatures for this final plat.
