Applicants,

Kittitas County Community Development Services (CDS) received your Forest Ridge Phase 2 (LPF-21-00006) Final Long Plat submittal on April 23, 2021. The application was put on hold until approval of Forest Ridge Ph 1, which received BOCC signature on August 17, 2021. Kittitas County staff has completed the review of your final plat submittal. As provided below, staff has the following comments, requirements, and/or revisions for your application that need to be addressed prior to considering this application complete for final approval and signature of the final plat mylars:

Community Development - Planning:

- Final mylars shall include the final plat number LPF-21-00006 in addition to the preliminary file number already provided.
- Condition #11 of the associated SEPA MDNS requires an Open Space Management Plan which describes, "the type
 of recreational uses and improvements allowed in the open space areas, and include a statement from a professional
 biologist demonstrating that the proposed uses, proposed improvements, and lot layout will avoid and minimize
 impacts to wildlife habitats. Approved recreational uses, as well as provisions for maintenance of any improvements
 shall be included in the Homeowners Association CCR's."
 - -CDS could not locate an Open Space Management Plan in the submittal materials addressing this condition. -The CC&R's provided appear to deal with common ownership maintenance obligations, but do not describe allowed open space area uses and improvements.
- Condition #7 of the associated SEPA MDNS requires that snow removal areas be indicated on Final Mylars. CDS could not locate these areas on the surveys submitted.
- All taxes for the applicable parcels associated with the final plat application must be paid prior to CDS signature.
