Washington State Department of Health has responded to the additional information with the following:

Kelly:

The response did not identify or enumerate the total number of new connections that are being proposed.

As noted, at this time, DOH records show the following:

- 992 Active connections
- 1501 Approved connections

While this shows 509 available connections, DOH has observed on the order of 4 to 6 applications for additional connections from Suncadia over the past 2 to 3 years. The construction of the homes for these applications does not occur instantly and does not change the active connections for the system – so the water system can continue to look like it has plenty of capacity.

DOH is seeking a summary, from Suncadia, that identifies each application that is seeking connections greater than "992" and the total number of connections being sought for each application.
