Kelly:

The Department of Health (DOH) Office of Drinking Water (ODW) has reviewed the application and has the following comments:

- The applicant indicates the water utility is “existing”. It appears that this is an existing on-site private well. Please confirm.
- If the applicant intends to connect all homes to a single well or multiple wells, then this would constitute a Group B public water system requiring review and approval from Kittitas County Health.
- If the applicant intends to install multiple individual or private wells, then this water usage is defined as a “project” by the Department of Ecology and all water use needs to be evaluated as a single quantity. In other words, even if several private wells for the individual homes, the total water usage cannot exceed either a single exempt well quantity of water or cannot exceed the total of any water rights.
