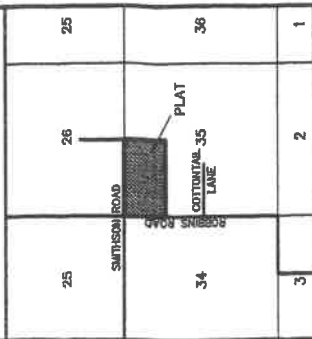

VICINITY MAP

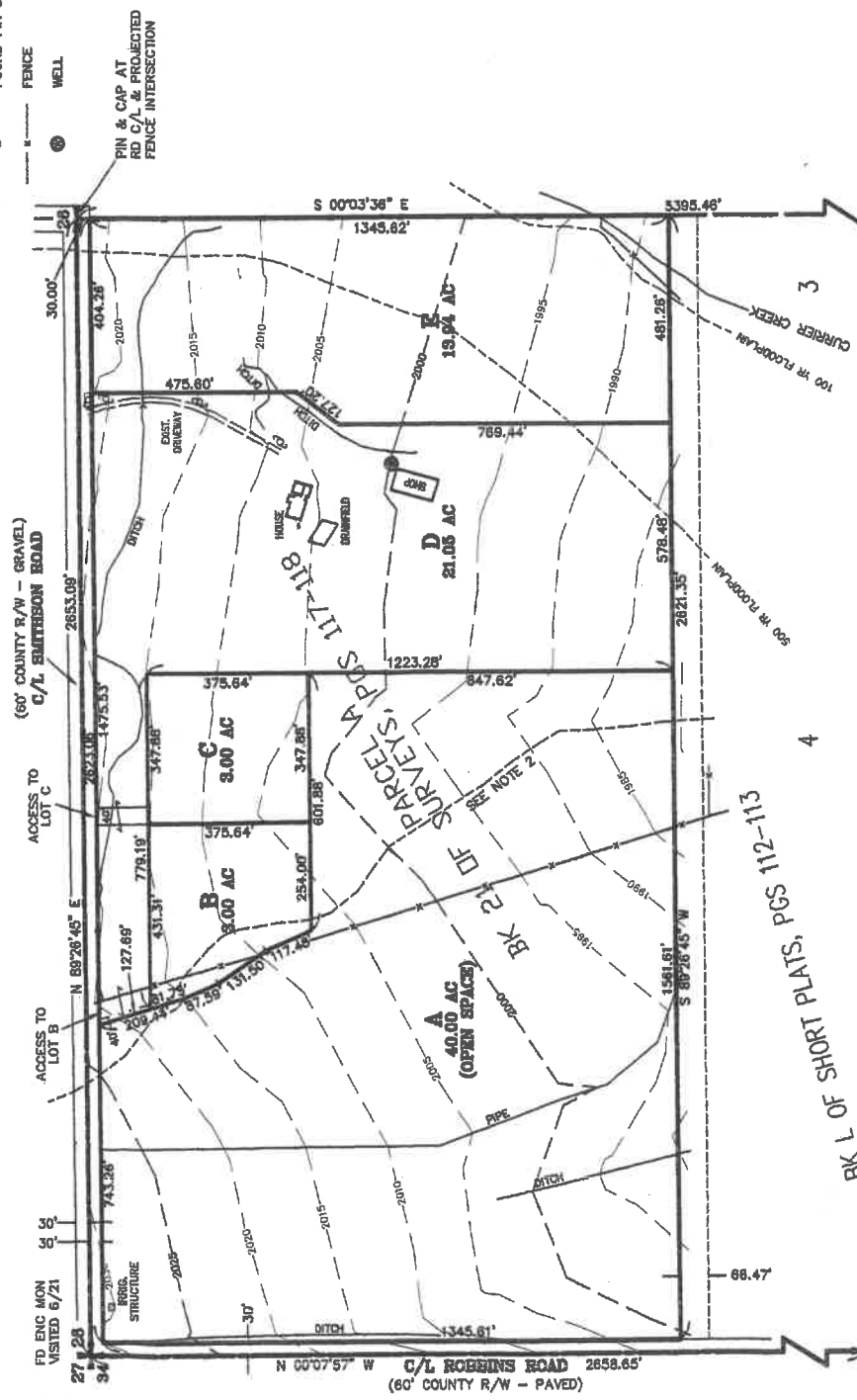
