

Project Description

The proposed project is limited to a plat alteration of the Plat of Sunshine Estates No. 2. The purpose of the proposed alteration is to remove or vacate the dedication to the use of the public forever as highways all roads, streets and alleys thereon. The existing roadways, Sunshine Avenue and Moonshine Lane, are currently privately owned and maintained, but open for public use. Due to the increasing costs related to normal repair and maintenance of the roadways, as well as incidents of vandalism, Sunshine Estates Community Club is requesting to restrict general public use and limit access to those lots currently served by the roadways. For those lots located outside of the boundaries of Sunshine Estates No. 2, but currently accessed by Sunshine Avenue and/or Moonshine Lane, necessary easements will need to be secured from Sunshine Estates Community Club by the respective lot owners.





