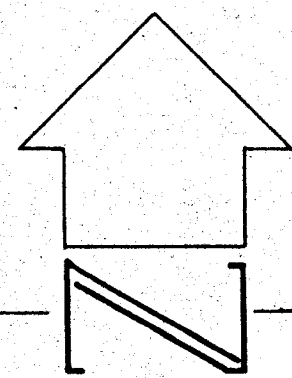

LOTS 41 THROUGH 45 SHALL BE HELD AS DRAINFIELD RESERVE AREA AND THE ENTIRE AREA OF EACH LOT MAY BE CLEARED AT A LATER DATE. WHEN AN AUTHORIZED SANITARY SEWER CONNECTION IS AVAILABLE, THESE LOTS SHALL REVERT BACK TO RECREATIONAL RESIDENTIAL PURPOSES. ALL OPEN AREAS SHALL BE SUBJECT TO UTILITY EASEMENTS.

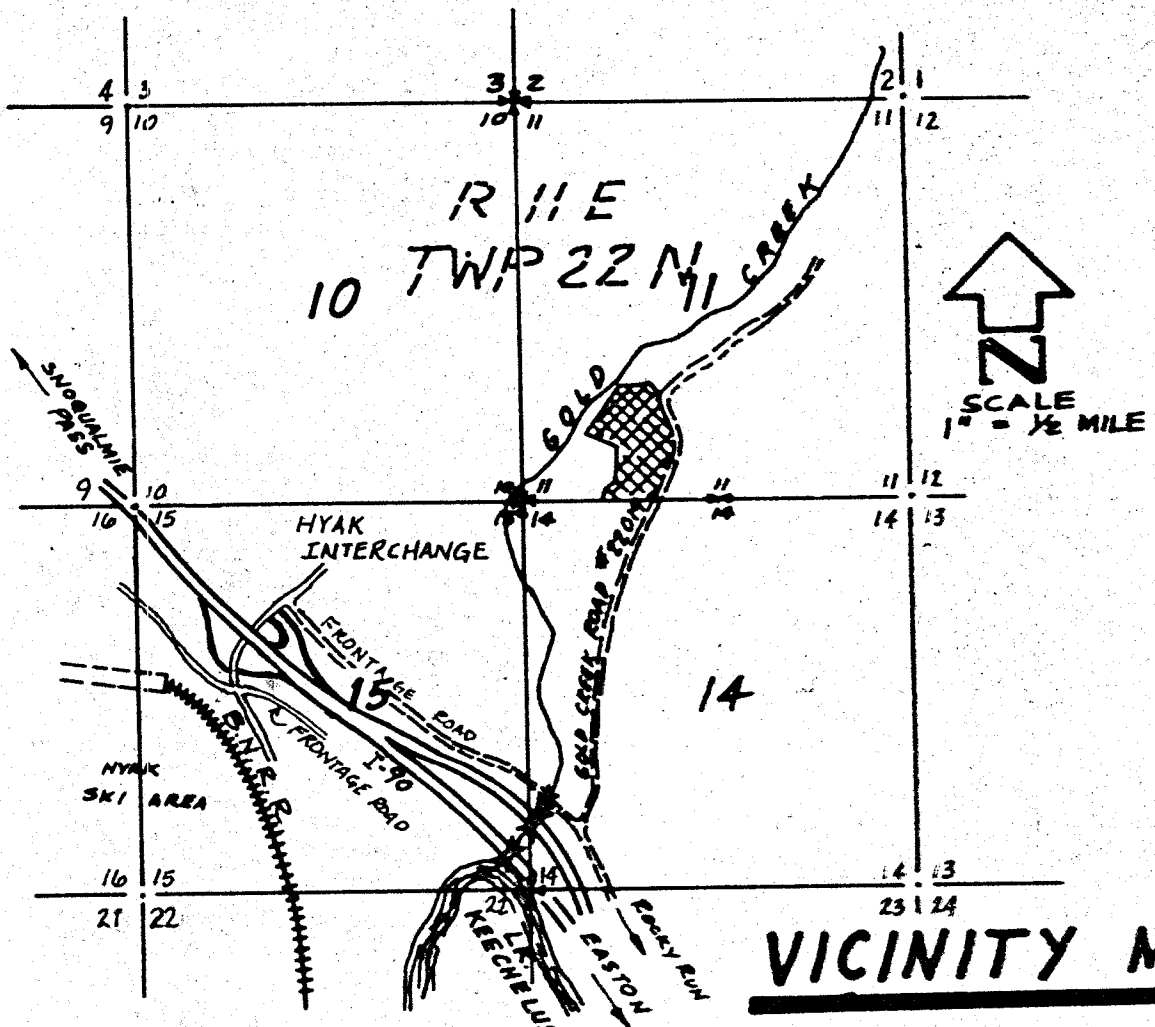
