D R Horton requests that you include this letter in the administrative record which County staff is providing to the County Commissioners. To limit any direct communication with the County Commissioners, D R Horton requests that you expeditiously forward this letter to the Commissioners at your very earliest opportunity.

D R Horton hereby discloses that on January 28, 2015 a representative of D R Horton made contact with County Commissioner Paul Jewell to ask if D R Horton could discuss items presented by staff at the January 20, 2015 closed record hearing for the Black Horse at Whiskey Creek Subdivision with the Commissioners. Commissioner Jewell responded that the closed record hearing is a quasi-judicial proceeding and therefore no Commissioner could have discussion with anyone other than staff or the other Commissioners regarding this matter. D R Horton makes this disclosure for transparency purposes. Neither that representative of DR Horton, nor any other, has had any substantive ex-parte communication with Commissioner Jewell or any other County Commissioner.
