Attached please find a SEPA Environmental Checklist and a Mitigated DNS for Public Utility District No. 2 of Grant County, Washington's (Grant PUD's) proposed Wanapum Dam Right Bank Stabilization Project. Grant PUD is proposing

to armor approximately 300 yards of shoreline on the right (west) bank from avian tower 4 to the Wanapum Dam. This work will be completed landward of the Ordinary High Water Mark and completed during low/normal flows so no inwater will occur. In May 2018, due to high run off flows of the Columbia River, the right bank near the Wanapum avian tower 4 required emergency stabilization. The shoreline was armored 100 yards downstream and 100 yards upstream of avian tower 4. Rip rap (~24 inch diameter) will be added to provide stability to the remaining 300 yards of shoreline to prevent further erosion and damage to the avian tower.
