Thank you but can you please answer the following question from the previous e-mail I sent today or tell me that the survey is not required to be filed with DAHP? Has this been filed? Please let me know if it has, so I can issue the shoreline exemption permit.

- a. Archaeological Survey & Reporting Standards. Archaeological surveys shall be completed by a professional archaeologist. Archaeological survey reports shall conform to DAHP's then-current reporting standards. Both DAHP and affected Native American tribes shall receive copies of completed archaeological survey reports, and have a reasonable opportunity (in no case less than fifteen days) to comment on their sufficiency before such reports shall be considered final. Final archaeological survey reports shall be filed with DAHP prior to the County's issuance of a permit, exemption, or other approval where the proposed project is not exempt under KCC 17B.05.010(B)(1)(a)*.
