Fencing will be installed by the GPUD Lands and Rec crew with materials currently in stock. Materials include fence posts and rails, equipment used to dig post holes, and minimal concrete to set posts. A small amount of excavation (not to exceed 2 feet) is required to install fence posts.

Additionally, three 4x4 wooden signposts along a pedestrian trail leading from the parking lot to the day use area. Minimal excavation will not exceed 2 feet, along with a small amount of concrete to set the posts.

The abandoned Vantage Riverstone marina and day use facility consisted of a three-dock marina, boardwalk trail, water fountain feature, and boat moorage which was constructed in the early 1990s on Grant PUD property.

The following species of fish have been documented using Wanapum Reservoir in the project vicinity: Spring Chinook salmon (*Oncorhynchus tshawytscha* - Endangered), summer and fall Chinook salmon (*O. tshawytscha*), summer steelhead (*O. mykiss* - Threatened), coho (*O. kisutch*), sockeye salmon (*O. nerka*), Dolly Varden/Bull trout (*Salvelinus confluentus* - Threatened), largemouth bass (*Micropterus salmoides*), smallmouth bass (*Micropterus dolmieu*), mountain whitefish (*Prosopium williamsoni*), kokanee (*O. nerka*), rainbow trout (*O. mykiss*), walleye (*Sander vitreus*), white sturgeon (*Acipenser transmontanus*) (WDFW 2012).

The open water portions of the reservoir in the vicinity of the site are used by waterfowl. WDFW Priority Species and Habitat data identify a Waterfowl Concentration Area and a Common Loon (*Gavia immer*) Use Area within the Wanapum Reservoir in the project vicinity (Grant PUD 2012, WDFW 2012). In general, waterfowl using the area eat plants, insects, crustaceans, mollusks and fish. The common loon eats aquatic invertebrates and fish. WDFW Priority Species and Habitat data also identify an occurrence of a western floater (*Anodonta kennerlyi*) north of the Project Site.

Although existing conditions at the Project Site include degraded riparian and upland habitats, they could be used by valued wildlife species. Documented wildlife species in the project vicinity include songbirds, loggerhead shrike (*Lanius ludovicianus*), turkey vulture (*Cathartes aura*), purple martin (*Progne subis*), bald eagle (*Haliaeetus leucocephalus*), night snake (*Hypsiglena torquata*), racer (*Coluber constrictor*), mule deer (*Odocoileus hemionus hemionus*) and elk (*Cervus elaphus*) (WDFW 2012). Apart from songbirds none of the above species have been documented using the Project Site. Priority terrestrial habitats adjacent to the Project Site include cliffs/bluffs and shrub-steppe (WDFW 2012).
