Your application for a Shoreline Substantial Development Permit (SD-14-00004) and Public Facilities Permit (PF-14-00002) which is for an Interpretive Center at the entrance to the Yakima River Canyon off of SR 821, located in a portion of Section 31 of Township 17 N, Range 19 E, WM in Kittitas County, Washington has been determined complete as of Friday, December 19, 2014.

Continued processing of your application will include, but is not limited to, the following actions:

1. Posting of the property by the applicant/authorized agent is required along each street frontage. Signage may be obtained at the Community Development Services offices during regular business hours.
2. A Notice of Application will be published in the newspaper and sent to all adjoining property owners, governmental agencies, and interested persons.
3. Consideration of written comments from all adjoining property owners, governmental agencies, and interested persons.
4. Notification of a Public Hearing date.

You may pick up the "Land Use Action" signs at the CDS office during regular business hours to be posted as shown on the site map attached to your Land Use Action signs and return the signed affidavit of posting to my attention. Applicants/Authorized Agents are encouraged to provide photos of site posting with the signed affidavit of posting. After this has been completed I will be able to start the process for issuance of the Notice of Application.
