**1. AGENCY ISSUING ADDENDUM:**

Public Utility District No. 2 of Grant County, Washington (Grant PUD)

**2. DESCRIPTION OF AGENCY ACTION:**

Grant PUD issued the original SEPA Determination Nonsignificance (DNS) and Environmental Checklist based upon preliminary design information for the Quilomene Floating Restroom on May 8, 2015. The DNS was submitted to the Washington Department of Ecology's (WDOE) online SEPA Registry. Comments were received from WDOE on June 1, 2015. The following information presented in the checklist has been updated.

In June of 2015, Washington Department of Fish and Wildlife (WDFW) and County Marine Patrols requested that four no-wake buoys be included into the project and be located outside Quilomene Bay to curtail beach erosion and protect cultural resources. A map of the approximate locations of the buoys is attached.

This addendum is intended to inform the recipients of the original SEPA DNS and the Environmental Checklist dated May 8, 2015 for the Quilomene Floating Restroom project to the above clarification the addition of four no-wake buoys. These changes have been reviewed and will not result in any new significant adverse impact, and does not change the original DNS.

**3. LOCATION OF PROPOSAL (A SUFFICIENT DESCRIPTION SHOULD BE GIVEN TO LOCATE THE SITE, IF ANY, BUT A COMPLETE LEGAL DESCRIPTION IS NOT REQUIRED):**

Access by boat, generally launched at Sunland Estates. Head north (upriver). Quilomene Bay is located on the right bank at river mile 433.

The project is located in Section 26, Township 22 N, Range 23 East, W.M. and Section 26, Township 19 North, Range 22 East W.M in Kittitas County, Washington.


