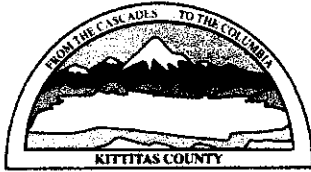

SEPA ENVIRONMENTAL CHECKLIST

Purpose of checklist:

You may need to consult with an agency specialist or private consultant for some questions. You may also attach or incorporate by reference additional studies reports. Complete and accurate answers to these questions often avoid delays with the SEPA process as well as later in the decision-making process.

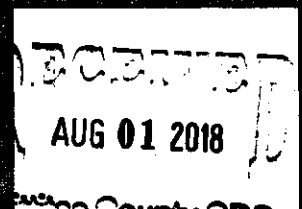
