Mr. Landen.

I want to make sure that you understand that we can accept a building permit from you, however it is still at your own risk. We are unable to issue building permit refunds, so if the Department of Ecology does not approve your Shoreline Variance Request (SV-14-00001) then you cannot proceed with your project and the fees associated with your permits will be forfeited. Also, please be aware that Kittitas County will not issue a building permit for this project until we have written documentation that the shoreline variance has been granted approval by the Department of Ecology.

The approval of your Shoreline Variance is up to the Department of Ecology; Kittitas County has completed our process. I would like to refer you back to Catherine Reed's letter dated August 4<sup>th</sup>, 2014 (see attached). Ms. Reed states that "the development described in this permit **may not legally begin** until this permit has been completed and properly evaluated by Ecology." She goes on to state that "...this permit is <u>void</u> until the information identified above is received by Ecology." Your architect submitted the requested information directly to Ms. Reed on August 11<sup>th</sup>, 2014 and I also transmitted the information to Ecology on August 18<sup>th</sup>, 2014 (see attached). I have not received any further correspondence regarding your permit since then.
