This consult is in reference to Short Plats SP-23-00010 NH2G. No ground disturbance has been proposed as a part of this undertaking.

This undertaking is located within the CCT Traditional Territories. We request any undertakings, particularly those involving ground disturbing activities, to have an IDP in place prior to implementation.

The proposed project lies within the traditional territory of the Moses-Columbia Tribe, 1 of the 12 constituent tribes of the Confederated Tribes of the Colville Reservation (CTCR), which is governed by the Colville Business Council (CBC). The CBC has delegated to the Tribal Historic Preservation Officer (THPO) the responsibility of representing the CTCR with regard to cultural resources management issues throughout the traditional territories of all of the constituent tribes under Resolution 1996-29. This area includes parts of eastern Washington, northeastern Oregon, the Palus territory in Idaho, and south-central British Columbia.

There are known cultural resources of precontact significance nearby and this particular plat is considered Low to High Risk for an inadvertent discovery according to the DAHP predictive model. This parcel has not been previously surveyed and a preliminary archaeological investigation would be prudent.

CCT requests a cultural resource survey prior to ensure compliance with all Section 106 and relevant cultural resource laws both federally and to the state of Washington.

Thank you for the opportunity to comment on SP-23-00010 NH2G concerning the dividing of the current 10-acre parcel into 2 parcels. Washington Department of Fish and Wildlife (WDFW) has reviewed the application and supporting documents. Our comments are regarding the project's impact on priority fish and wildlife habitats, particularly shrubsteppe habitats. Specifically, to ensure that if the application is approved that the development will not result in loss of Fish and Wildlife Habitat Conservation Areas (FWHCA) under Kittitas County Critical Areas Ordinance (CAO).

The current critical areas map does not list shrubsteppe as occurring on the property, yet the WDFW Priority Habitats and Species (PHS) map does show shrubsteppe as likely occurring on parcel. Shrubsteppe is listed as a priority habitat under the FWHCA of the CAO. If this parcel were to be developed further, WDFW requests that there would be conversations on how to minimize impacts to this priority habitat and for impacts that cannot be minimized, discussions on how to mitigate for impacts should occur. WDFW would also like to request that the county include shrubsteppe in the county's CAO layer so that future areas of interaction between development and shrubsteppe can be appropriately identified. WDFW would be happy to assist with this task if needed.
