FINDINGS OF FACT Mt. Baldy Short Plat File Number SP-08-00022

Pursuant to RCW 58.17.195, the Kittitas County Community Development Services Department formally establishes the following Findings of Fact:

- 1. The Mt. Baldy Short Plat (SP 08-00022) has satisfied all current subdivision and zoning requirements. This short plat has been reviewed and approved in conformance with the Kittitas County Subdivision (Title 16) and Zoning (Title 17) Codes.
- 2. A notice of application for the Mt. Baldy Short Plat (SP 08-00022) was mailed to adjacent landowners located within 500 feet of any portion of the boundary of the proposal's tax parcel. Notice was given to and published in the official newspaper of record for Kittitas County, and notice was posted to the Kittitas County Website, all in conformance with the Kittitas County Project Permit Application Process (Title 15A)
- 3. The applicant has demonstrated to the satisfaction of the County Environmental Health Director the availability of potable water supplies.
- 4. The applicant shall connect to the existing Turf Trails Water Company water system and provide written approval from the Washington State Department of Health for modifying the current public water system from 9 connections to 12 prior to final plat approval. Applicant shall meet all local and state requirements pertaining to water use..
- 5. The applicant has demonstrated that sewage disposal will be provided by individual septic systems.
- 6. The applicant has demonstrated to the County Public Works Department that the access provisions are in the interest of public safety and general welfare.
- 7. A statement indicating the County's intent to approve this short plat, together with a reduced photocopy depicting the lot configurations and proposed acreage was mailed to known adjacent property owners and parties of record on December 12, 2008.
- 8. Kittitas County Community Development Services Department completed a Critical Areas Review. No critical areas were identified on this Short Plat.
- 9. The Mt Baldy Short Plat (SP 08-00022) is located on or within one thousand feet of land zoned Commercial Agriculture; a plat note has been attached reading the following: "The subject property is within or near land used for agriculture on which a variety of commercial activities may occur that are not compatible with residential development for periods of varying duration. (RCW 36.70A.060(1)) Commercial natural resource activities performed in accordance with county, state and federal laws are not subject to legal action as public nuisances." (RCW 7.48.305).
- 10. The property lies within the Ellensburg Water Irrigation District. The property owners shall adhere to the general requirements of the Ellensburg Water Irrigation District.

Administratively approved short plats must be recorded with the County Auditor and shall not be deemed approved until officially filed.
