Keith Smith, landowner, submitted a complete application on October 9, 2008 for a 4 lot Short Plat pursuant to Kittitas County Code 16.32 on approximately 16.52 acres of land that is zoned Rural-3. The subject property is located northeast of I-90, west of Lake Kachess, on Lake Kachess Rd, Easton, WA 98925, and is located in a portion of Section 13, T21N, R12E, WM, in Kittitas County. Map number 21-12-13000-0008.

Written comments from the public may be submitted to Kittitas County Community Development Services no later than October 31, 2008, after which a SEPA threshold determination will be issued pursuant to RCW 43.21C (State Environmental Policy Act) and WAC 197-11-355 (Optional DNS Process). This may be the only opportunity to comment on the environmental impacts of this proposal pursuant to SEPA, as a Determination of Non-Significance (DNS) is expected to be issued. A copy of this subsequent threshold determination will be available to the public upon request. This proposal may include, incorporate or require mitigation measures under applicable codes regardless of whether a Determination of Significance (DS) is issued and subsequent Environmental Impact Statement (EIS) is prepared.
