ORIGINAL PARCEL DESCRIPTION

SECTION 36, TOWNSHIP 18 NORTH, RANGE 17 EAST, W.M., IN THE COUNTY OF KITTITAS, STATE OF WASHINGTON;

EXCEPT THE RIGHT OF WAY OF ROBINSON CANYON ROAD ALONG THE NORTH BOUNDARY THEREOF:

AND EXCEPT THE RIGHT OF WAY OF COVE COUNTY ROAD ALONG THE EAST BOUNDARY THEREOF;

AND EXCEPT THE RIGHT OF WAY OF WEAVER COUNTY ROAD ALONG THE SOUTH BOUNDARY THEREOF;

AND EXCEPT THAT PORTION OF THE SOUTH 1/2 OF SECTION 36, TOWNSHIP 18 NORTH, RANGE 17 EAST, W.M., IN THE COUNTY OF KITTITAS, STATE OF WASHINGTON, WHICH IS DESCRIBED AS FOLLOWS:

BEGINNING AT THE SOUTH QUARTER CORNER OF SAID SECTION 36, WHICH IS THE TRUE POINT OF BEGINNING; THENCE NORTH 89°45'03" EAST, ALONG THE SOUTH LINE OF SAID SECTION 36, 1,339.82 FEET; THENCE NORTH 01°03'06" EAST, 353.69 FEET; THENCE NORTH 35°11'20" WEST, 237.24 FEET; THENCE NORTH 42°53'29" WEST, 107.50 FEET; THENCE NORTH 76°08'54" WEST, 130.07 FEET; THENCE NORTH 42°53'49" WEST, 1,110.78 FEET; THENCE SOUTH 85°33'18" WEST, 1,037.09 FEET; THENCE NORTH 86°04'11" WEST, 1,854.39 FEET, MORE OR LESS, TO THE WEST LINE OF SAID SECTION 36; THENCE SOUTH 00°49'37" WEST, ALONG SAID WEST LINE, 1,495.90 FEET, MORE OR LESS, TO THE SOUTHWEST CORNER OF SAID SECTION 36; THENCE SOUTH 89°23'45" EAST. ALONG THE SOUTH LINE OF SAID SECTION 36, 2,651.68 FEET, MORE OR LESS, TO THE POINT OF BEGINNING.

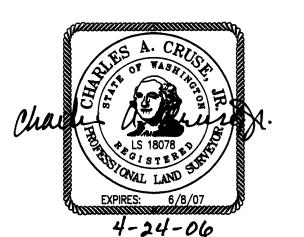

AND EXCEPT LOTS 1 THROUGH 17, INCLUSIVE, AS DELINEATED ON PAGE "7 OF 8" OF THAT CERTAIN BOUNDARY LINE ADJUSTMENT FOR HIGH VALLEY LAND, INC., FILED ON FEBRUARY 12, 1997, IN BOOK 22 OF SURVEYS, PAGES 162 THROUGH 169, AND RECORDED UNDER KITTITAS COUNTY AUDITOR'S FILE NO. 199702120003, A COPY OF WHICH IS ALSO FILED IN BOOK E OF SHORT PLATS, PAGES 134 THROUGH 141 AND RECORDED UNDER KITTITAS COUNTY AUDITOR'S FILE NO. 199702120004, ALL IN THE RECORDS OF KITTITAS COUNTY, STATE OF WASHINGTON; BEING A PORTION OF THE NORTHWEST QUARTER OF SECTION 36, TOWNSHIP 18 NORTH, RANGE 17 EAST, W.M., KITTITAS COUNTY, STATE OF WASHINGTON.

AND EXCEPT THE WEST 30 FEET AS DEDICATED AND DELINEATED ON PAGES "1 OF 8" AND "7 OF 8" OF THE HIGH VALLEY LAND, INC. NO. 1, NO. 2 AND NO. 3 SHORT PLATS AS FILED ON FEBRUARY 12, 1997, IN BOOK E OF SHORT PLATS, PAGES 134 THROUGH 141 AND RECORDED UNDER KITTITAS COUNTY AUDITOR'S FILE NO. 199702120004, THE ORIGINAL OF WHICH IS FILED IN BOOK 22 OF SURVEYS, PAGES 162 THROUGH 169, AND RECORDED UNDER AUDITOR'S FILE NO. 199702120003, ALL IN THE RECORDS OF KITTITAS COUNTY, STATE OF WASHINGTON; BEING A PORTION OF THE NORTHWEST QUARTER OF SECTION 36, TOWNSHIP 18 NORTH, RANGE 17 EAST, W.M., KITTITAS COUNTY, STATE OF WASHINGTON.

### NOTES:

- 1. THIS SURVEY WAS PERFORMED USING A TOPCON GTS-3C TOTAL STATION. THE CONTROLLING MONUMENTS AND PROPERTY CORNERS SHOWN HEREON WERE LOCATED, STAKED AND CHECKED FROM A CLOSED FIELD TRAVERSE IN EXCESS OF 1:10,000 LINEAR CLOSURE AFTER AZIMUTH ADJUSTMENT.
- 2. A PUBLIC UTILITY EASEMENT 10 FEET IN WIDTH IS RESERVED ALONG ALL LOT LINES. THE 10 FOOT EASEMENT SHALL ABUT THE EXTERIOR PLAT BOUNDARY AND SHALL BE DIVIDED 5 FEET ON EACH SIDE OF INTERIOR LOT LINES. SAID EASEMENT SHALL ALSO BE USED FOR IRRIGATION.
- 3. PER RCW 17.10.140 LANDOWNERS ARE RESPONSIBLE FOR CONTROLLING AND PREVENTING THE SPREAD OF NOXIOUS WEEDS. ACCORDINGLY, THE KITTITAS COUNTY NOXIOUS WEED BOARD RECOMMENDS IMMEDIATE RESEEDING OF AREAS DISTURBED BY DEVELOPMENT TO PRECLUDE THE PROLIFERATION OF NOXIOUS WEEDS.
- 4. FOR SECTION SUBDIVISION, SECTION AND QUARTER SECTION CORNER DOCUMENTATION AND ADDITIONAL SURVEY INFORMATION, SEE BOOK 22 OF SURVEYS, PAGES 162-169, BOOK E OF SHORT PLATS, PAGES 134-141 AND THE SURVEYS REFERRED THEREON.
- 5. MAINTENANCE OF THE ACCESS IS THE RESPONSIBILITY OF THE PROPERTY OWNERS WHO BENEFIT FROM ITS USE.
- 6. AN APPROVED ACCESS PERMIT WILL BE REQUIRED FROM THE DEPARTMENT OF PUBLIC WORKS PRIOR TO CREATING ANY NEW DRIVEWAY ACCESS OR PERFORMING WORK WITHIN THE COUNTY ROAD RIGHT OF WAY.
- 7. ANY FURTHER SUBDIVISION OR LOTS TO BE SERVED BY PROPOSED ACCESS MAY RESULT IN FURTHER ACCESS REQUIREMENTS. SEE KITTITAS COUNTY ROAD STANDARDS.
- 8. MAILBOX(S) SHALL BE "BREAK—AWAY" DESIGN AND BE AS APPROVED BY THE U.S. POSTAL SERVICE. SEE WSDOT STANDARD DRAWINGS H—12 SHEET 1—3.
- 9. THE SUBJECT PROPERTY IS WITHIN OR NEAR EXISTING AGRICULTURAL OR OTHER NATURAL RESOURCE AREAS ON WHICH A VARIETY OF ACTIVITIES MAY OCCUR THAT ARE NOT COMPATIBLE WITH RESIDENTIAL DEVELOPMENT FOR CERTAIN PERIODS OF VARYING DURATION. AGRICULTURAL OR OTHER NATURAL RESOURCE ACTIVITIES PERFORMED IN ACCORDANCE WITH COUNTY, STATE AND FEDERAL LAWS ARE NOT SUBJECT TO LEGAL ACTION AS PUBLIC NUISANCES. KITTITAS COUNTY HAS ADOPTED RIGHT TO FARM PROVISIONS CONTAINED IN SECTION 17.74 OF THE KITTITAS COUNTY ZONING CODE.
- 10. ACCORDING TO KITTITAS RECLAMATION DISTRICT (KRD) RECORDS, LOT 1 HAS 16 IRRIGABLE ACRES; LOT 2 HAS 11 IRRIGABLE ACRES; LOT 3 HAS 15 IRRIGABLE ACRES; LOT 4 HAS 13 IRRIGABLE ACRES; LOT 5 HAS 16 IRRIGABLE ACRES; LOT 6 HAS 17 IRRIGABLE ACRES; LOT 7 HAS 5 IRRIGABLE ACRES; LOT 8 HAS 12 IRRIGABLE ACRES; LOT 9 HAS 19 IRRIGABLE ACRES; LOT 10 HAS 25 IRRIGABLE ACRES; LOT 11 HAS 11 IRRIGABLE ACRES; LOT 12 HAS 8 IRRIGABLE ACRES; LOT 13 HAS 11 IRRIGABLE ACRES; LOT 14 HAS 20 IRRIGABLE ACRES; LOT 15 HAS 20 IRRIGABLE ACRES; LOT 16 HAS 20 IRRIGABLE ACRES; LOT 17 HAS 20 IRRIGABLE ACRES; LOT 18 HAS 20 IRRIGABLE ACRES; LOT 19 HAS 19 IRRIGABLE ACRES; LOT 20 HAS 20 IRRIGABLE ACRES; LOT 21 HAS 18 IRRIGABLE ACRES; LOT 22 HAS 20 IRRIGABLE ACRES; LOT 23 HAS 16 IRRIGABLE ACRES; LOT 24 HAS 11 IRRIGABLE ACRES. KRD WATER MAY ONLY BE APPLIED TO IRRIGABLE ACREAGE.
- 11. FULL PAYMENT OF ANNUAL KRD ASSESSMENT IS REQUIRED REGARDLESS OF THE USE OR NON-USE OF WATER BY THE OWNER.
- 12. THE LANDOWNERS MUST PROVIDE FOR THE APPOINTMENT OF ONE WATER MASTER FOR EACH TURNOUT, WHO SHALL BE RESPONSIBLE FOR ORDERING WATER FOR THE ENTIRE PLAT. THE WATER MASTER WILL BE RESPONSIBLE FOR KEEPING WATER USE RECORDS FOR EACH LOT. KRD WILL ONLY BE RESPONSIBLE FOR KEEPING RECORDS ON THE TOTAL WATER ORDERED AT THE KRD TURNOUT.
- 13. KRD OPERATIONS AND MAINTENANCE ROADS ARE FOR DISTRICT USE ONLY. RESIDENTIAL AND RECREATIONAL USE IS PROHIBITED.
- 14. KRD IS ONLY RESPONSIBLE FOR DELIVERY OF WATER TO THE HIGHEST FEASIBLE POINT IN EACH 160 ACRE UNIT OR DESIGNATED TURNOUT. THE KRD IS NOT RESPONSIBLE FOR WATER DELIVERY LOSS (SEEPAGE, EVAPORATION, ETC.) BELOW THE DESIGNATED TURNOUT.
- 15. KITTITAS COUNTY RELIES ON ITS RECORD THAT A SUPPLY OF POTABLE WATER EXISTS. KITTITAS COUNTY DOES NOT GUARANTEE A LEGAL RIGHT TO WITHDRAW ANY GROUND WATER.
- 16. RESIDENTIAL AND ACCESSORY BUILDING LIGHTING MUST BE REFLECTED AND DIRECTED DOWNWARD TO MINIMIZE GLARE AND NIGHTIME LIGHT POLLUTION.
- 17. PRIVATE ROADS SHALL CONFORM WITH THE REQUIREMENTS AND STANDARDS PRESCRIBED IN KITTITAS COUNTY CODE 12.12 (JUNE 2004).

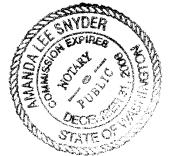

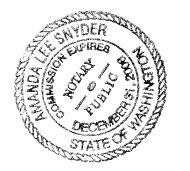
