Hi Jeff:

Attached are few photographs of the Teanaway River during a high water event in 2009. The FEMA floodplain delineation in the land use application material you provided appears to differ from the location where the river was in 2009. The property appears to have major drainage issues, with standing water evident on significant portions of one of the proposed parcels. Additionally, the "road" that exists between the property and the Teanaway River acts as a "dike" and artificially blocks the river from the floodplain. This impacts fish habitat of the listed and resident fish in the Teanaway River. This "road/dike" feature " is likely not engineered to any accepted standard and reliance on it as protection from flooding is highly questionable. This section of the Teanaway River appears to be dynamic laterally when compared to upstream or downstream segments. It is a depositional area and is diverse and comparatively complex habitat within the reach. Mason Creek is an issue as well with development potentially impacting this fish bearing tributary.
