


LEGAL DESCRIPTIONS

PARCEL A

Parcel A of that certain survey as recorded <u>January 29</u> 1992 in Book 18 of Surveys at page(s) // 2 , under Auditor's File No. 546264, Records of Kittlas County, Washington; being a portion of Government Lots 3 and 4, Section 5, Township 16 North, Range 20 East, W.M., Kittitas County, Washington.

PARCEL B

Parcel B of that certain survey as recorded <u>January 29</u>, 1992 in Book 18 of Surveys at page(s) // 2 , under Auditor's File No. <u>546264</u>, Records of Kittitas County, Washington; being a portion of Government Lots 2 and 3, Section 5, Township 16 North, Range 20 East, W.M., Kittitas County, Washington.

PARCEL C

Parcel C of that certain survey as recorded January 29 1992 in Book 18 of Surveys at page(s) //2 , under Auditor's File No. <u>Sy626y</u>, Records of Kittitas County, Washington; being a portion of Government Lots 2 and 3, Section 5, Township 16 North, Range 20 East, W.M., Kittitas County, Washington.

PARCEL D

That portion of Government Lots I and 2, Section 5, Township 16 North, Range 20 East, W.M., Kittitas County, Washington, which lies north and west of the north and west boundary line of the right of way of the Wipple Creek Wasteway, and lies easterly of the following described line:

PARCEL D (cont.)

Beginning at the northeast corner of said Section 5, thence S 89°21'20" W, along the north line of said Section 5, 1488.10 feet to the true point of beginning of said line; thence S 03°18'55" W, 133.06 feet; thence S 08°36'05" E, 50.26 feet; thence S 16°57'05" E, 40.14 feet; thence S 27°32'42" E, 43.53 feet; thence S 44°26'13" E, 167.95 feet; thence S 02°26'16" E, 203.78 feet, more or less, to the north right of way of the Kittitas Reclamation District Wipple Creek Wasteway and the terminus of said line;

EXCEPT right of way for Fourth Parallel County Road along the north line; AND EXCEPT right of way for the Kittitas Reclamation District.

NOTES:

1. The section and quarter section corners shown hereon were originally set by the GLO in 1867 as "charred stake and post". The Fourth Standard Parallel was resurveyed in 1910 by Fred Brown and surveyed in 1931-32 by the US Bureau of Reclamation. Due to road construction in the area, original evidence has been obliterated. In October of 1991, I found the

W 1/4 COR SEC. 32 - Found GLO brass cap mon, See Bk, 18 of Surveys, page 71.

- 3. The location of the irrigation ditch as shown is based on the US Bureau of Reclamation plans on file with the Kittitas Co. Dept. of Public Works. The ditch fits the r/w plans on the portion of the ditch located on the southern boundary of Lots B, C and D and the eastern half of Lot A, but is south of the calculated location on the western portion of Lot A.
- 4. The basis of bearings as shown hereon is 5 00°55'48" W. along the west boundary of the NW 1/4 of Section 5, as is the survey filed in Book 18 of Surveys, page 71.
- 5. This survey was performed using a Topcon GTS-3C total station. The controlling monuments and property corners shown hereon were located, staked and checked from a closed field traverse in excess of 1:10,000 linear closure after azimuth adjustment.
