(SP-15-00007)

Notice is hereby given that on April 25, 2016, conditional preliminary approval was granted to Shirley Riste, landowner, for a short subdivision of 71.17 acres into 3 lots consisting of one 20 acre parcel, one 22.22 acre parcel, and one 24.92 acre parcel. The subject properties are located approximately 18 miles south of Ellensburg at 6620 State Route 821 (Yakima Canyon), in a portion of Section 33, T15N, R19E, WM in Kittitas County, bearing Assessor's map numbers 15-19-33000-0002 and 15-19-33000-0007.
