Notice is hereby given that on October 26, 2016, conditional preliminary approval was granted to Joan Nelson, landowner, has submitted a preliminary agriculture short plat application to subdivide approximately 59.7 acres into 3 lots, one 44.11 acre lot, one 6 acre lot and one 8.92 acre lot. The subject property is zoned Agriculture 20 and is located approximately 3.5 northeast of the City of Ellensburg at 5790 Wilson Creek Road, in a portion of Section 17, T18N, R19E, WM in Kittitas County, bearing Assessor's map number 18-19-17000-0012 and 18-19-17000-0017.


