### SE-15-00001

NOTICE IS HEREBY given that pursuant to WAC 197-11-340, Kittitas County Community Development Services did on February 13, 2015 issue a Determination of Non-Significance (DNS) for Kittitas County Code Amendment.

The lead agency for this proposal has determined that the proposal will not have a probable significant adverse impact on the environment. An Environmental Impact Statement (EIS) is not required under RCW 43.21C.030 (2)(c) and WAC 197-11. This decision was made after review of a completed environmental checklist and other information on file with the lead agency.

This DNS is issued under WAC 197-11-330; the lead agency will not act on this proposal for 15 days. Any person, affected tribe, or agency may submit comments to the lead agency within 15 days of the date of issuance of the DNS. 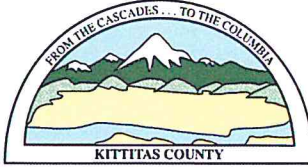



**There may be uses that exist within the Bowers Field airport district that have activities that are compatible with Light Industrial zone classifications and were not corrected during the effort to bring the Code into compliance in early 2014. This is noticeable in not allowing an “Airport” in the Airport district. Vehicle service, whether agricultural or non-agricultural related industries should also be included.**

**Regarding the second request, the low snowpack from this season is likely to create a draught within the County during the end of this summer creating the need for permitting cisterns for residential uses. Our current ordinance only permits such activity when there is no other source of water for any residential activities. The cisterns could only be used for provision of water for the single family residence, and could not be used for any multi-family, subdivision or commercial activity. The amount of water taken from the overall supply from such a change is negligible, would not in any way deplete the amount of water available to the rest of the County or Yakima Basin.**

This is considered an emergent issue since existing light industrial uses are not allowed within the zone even though some of the uses are allowed within the “Rural Non-LAMIRD” Plan designated areas. Currently, the airport at Bower’s Field is not listed as an allowed use and therefore, would be classified as non-conforming. It is proposed to allow such a use with the approval of a conditional use permit. While the proposal would require a conditional use permit for the expansion of the airport, it would also make the existing use and uses conforming to the Code.**

**The proposal to amend KCC 13.25 is designed to permit the use and development of cisterns in areas that may be susceptible to lack of potable water and by damage from fire as a result of the draught. While the cisterns would still be required to meet State law and other County regulations, they would be permitted without showing that no other potable water exists to the site. This would permit dwellings the ability to obtain water in times of draught or fire hazard.**

*The proposed amendments to the Kittitas County Code and Comprehensive Plan are not likely to affect plants, animals, or marine life over what already occurs under current County Regulations. The proposed amendments do not include new uses or changes that would result in a significant impact upon plants, animals, fish or marine life. The more liberal use of cisterns in the County might increase single family development in some spots but not significantly. The use of cisterns would increase traffic of large trucks moving water to the cistern structure.*
