The purpose of this project is to design and construct a commercial access road to serve as an access to the site from Sparks Road with minimal changes to the topography. Example: Truck and Trailer and other commercial vehicles. The project site is 16.51 acres, however only 0.86 acres will be disturbed as part of the project.

Kladnick, ashy sandy loam with 0 to 3% slopes. It is part of HSG A, and is well drained, with a high infiltration rate.

8752.5 cubic yards of fill will need to be imported in order to construct the road at 2% and tie into Sparks Road.

Temporary and permanent erosion control methods will be used to ensure the project site and surrounding area are not impacted by erosion.

0.28 acres of the site will be paved, meaning that 1.7% of the site will be impervious after project completion.

As described in full detail in the SWPPP, maintaining existing vegetation, straw wattles, silt fence, seeding, surface roughening, crushed rock placement, and dust control will be used to reduce/control erosion.

Asphalt preparation for the paved road will result in emissions briefly during the construction phase. Dust emissions will result from the on-site grading and filling.
