KCPW Fairview Road Culvert Replacement Project

Description: The proposed project will widen Fairview Rd to County standards and replace

Building Partnerships; Building Communities

three culverts, two of which are undersized and failing. The project will create a new channel alignment, through use of one larger culvert to replace the 3 existing culverts. This replacement will provide fish passage and eliminate maintenance requirements. The project is a re-design to create a more effective, simple, and safe channel system mitigating the risks associated with the failing and ineffective

existing infrastructure.

Location: The project site is located approximately five miles northeast of Ellensburg, WA. The project site

is in Section 14, T18N, R19E, where Coleman Creek crosses Fairview Rd.
