Hello,

I'm following up on a voicemail I left at 509-201-0775 in late July or early August.

Holly Myers left Kittitas County to join the Yakima Health District last year, so I will be finalizing the permitting process for your permit facility. I met with the County's CDS Director and Planning Official to determine the land use issues that paused the permitting process last year, and how we can move forward.

MRM construction will need to resubmit the SEPA, which was never formally processed or submitted at CDS. I have an updated cover letter and checklist that will need to be submitted, with fees paid to CDS and Public Works for review of the SEPA (all public health SEPA review fees will be waived).

Please let me know that you have received this email, and contact me at your earliest convenience for guidance on submission of an updated SEPA checklist.
