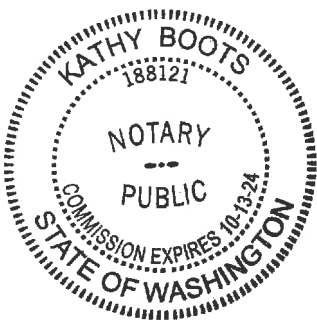

The proposed project would construct two storage ponds to hold septage that is pumped from a variety of commercial and residential sources. The project is proposed on a site that is zoned Agricultural 20.
