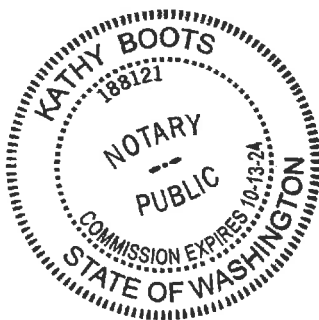

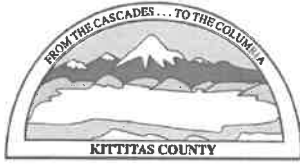

The proposal is for the installation and supply of power to the main power supply panel to service new fish screens. The project will include an emergency backup generator (with concrete foundation and containment), a 12.47 kV/480 V transformer/breaker/automatic transfer switch assembly (with concrete foundation and containment) and storm drainage. The project is located at Rosa Diversion Dam, located on the Yakima River along State Route 821, in Section 33, Township 15N, Range 19E, W.M. in Kittitas County.
