### NOTICE OF APPLICATION

Project Name (File Number): Pierson (SE-21-00014)

Applicant: Ski Tur Valley Maintenance Association (STVMA)

**Location:** The project area is located in the northwest portion of Parcel # 328235 along the east bank of Gold Creek, approximately 0.2 miles north of the intersection of Chikamin Peak Road & Gold Creek Lane, Section 11, Township 22, Range 11 in Kittitas County.

**Proposal:** Ski Tur Valley Maintenance Association (STVMA) is proposing the construction of five bio-engineered deflection barbs made of tree boles with branches, along approximately 400 feet of the east bank of Gold Creek to prevent creek overflow or relocation that would destroy residences and upland forests. The SEPA application is associated with Shoreline Exemption Permit SX-21-00009 and a future Washington Department of Fish & Wildlife Standard HPA Application. The zoning where the proposed project is located is Planned Unit Development within a Type 1 LAMIRD.

This proposal may include, incorporate, or require mitigation measures under applicable codes regardless of whether a Determination of Significance (DS) is issued, and subsequent Environmental Impact Statement (EIS) is prepared.
