Kelly:

The response from the water system does not meet DOH needs – they are simply providing a copy of their well log and WFI:

- The well log shows a well flow rate based on 1 hour flow test, which is not sufficient based on DOH standards.
- The WFI simply shows the water system has one (1) approved connection, so it does not show any additional capacity.

For DOH to be comfortable with the “expansion” of the water system, we need an evaluation of capacity, to be completed by a Professional Engineer (PE) licensed in the State of Washington. DOH suggests that if/when the water system contracts with a PE, the PE contact DOH, so we can discuss our specific needs and streamline their engineering services to be most cost-efficient.
