NOTICE IS HEREBY given that pursuant to WAC 197-11-355 and RCW 43.21C.030(2)(c), Kittitas County Community Development Services did, on April 14, 2022, issue a Mitigated Determination of Non-Significance (MDNS) on the proposed SEPA application submitted by Bill Mundy. The is proposing to do road improvements and a stormwater management system including 626 cubic yards of cut and 2,329 cubic yards of fill. The SEPA application is associated with Kittitas County Public Works Grading Permit GP-21-00031. The project is proposed on a site that is zoned Agricultural 5 and Forest and Range within a Rural Residential and Rural Working Land Use designation. The subject properties are parcel #'s: 504636, 17778, 17779, 17780 and 355035, approximately 3 miles East of Cle Elum, WA in part of Sections 27, 28, 33, and 34, Township 20N, Range 16E, W.M., Kittitas County. applicant is proposing the construction of utilities and infrastructure for eight (8) single-family lots. The SEPA application is associated with a Kittitas County Grading Permit (GP-21-00010). The project is proposed on a site that is zoned LAMIRD Type 1 Residential within a LAMIRD Land Use designation. Tax parcels 418135, 408135, 398135, 538135, 548135, 378135 and 368135 located off of Tanner Way and SR906, approximately 0.6 miles north of the intersection of Hyak Dr & State Route 906, in the south half of the southeast quarter of Section 9, Township 22, Range 11 in Kittitas County.

The lead agency for this proposal has determined that the proposal will not have a probable significant adverse impact on the environment. An Environmental Impact Statement (EIS) is not required under RCW 43.21C and WAC 197-11-355. Timely appeals must be received no later than 5:00pm, April 28, 2022.
