NOTICE IS HEREBY given that pursuant to WAC 197-11-355 and RCW 43.21C.030(2)(c), Kittitas County Community Development Services did, on July 20, 2022, issue a Mitigated Determination of Non-Significance (MDNS) on the proposed SEPA application submitted by Devin Casto. The applicant is proposing to engineer and shore up a landslide and repair Palouse Road. The applicant intends to install a sheet pile wall so that the road can be rebuilt and then install a poured concrete retaining wall at the base of the landslide. This SEPA application is associated with Kittitas County Public Works Grading Permit GP-22-00013. The subject property is in a Rural 5 zoning district with a Rural Residential land use designation. The property is located at 561 Palouse Road Cle Elum, WA 98922, Tax parcel number 953974. It is Lot 1 of the Walmer Short Plat and in Section 07, Township 19, Range 16 in Kittitas County.

The lead agency for this proposal has determined that the proposal will not have a probable significant adverse impact on the environment. An Environmental Impact Statement (EIS) is not required under RCW 43.21C and WAC 197-11-355.
