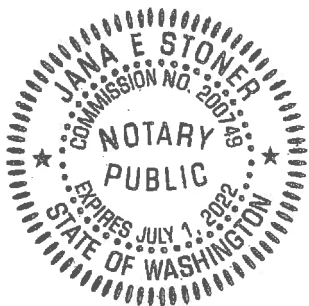

Project Name (File Number): Casto (SE-22-00054)

Applicant: Devin Casto

Location: 561 Palouse Road Cle Elum, WA 98922, Tax parcel number 953974. Lot 1 of the Walmer Short Plat. In Section 07, Township 19, Range 16 in Kittitas County.

Proposal: The applicant, Devin Casto, is proposing to engineer and shore up a landslide and repair Palouse Road. The applicant intends to install a sheet pile wall so that the road can be rebuilt and then install a poured concrete retaining wall at the base of the landslide. This SEPA application is associated with Kittitas County Public Works Grading Permit GP-22-00013. The subject property is in a Rural 5 zoning district with a Rural Residential land use designation.

Written Comments from the public may be submitted to the Kittitas County Community Development Services no later than **Monday June 13, 2022 at 5:00 p.m.**, after which a SEPA threshold determination will be issued pursuant to 43.21C RCW (State Environmental Policy Act). A Mitigated Determination Non-Significance (MDNS) is expected to be issued using the Optional DNS Process under WAC 197-11-355. Mitigation measures may include but are not limited to: Having a geotechnical expert on site during work and having a fully approved grading plan with plans for stormwater locations prior to starting work. This may be the only opportunity to comment on the environmental impacts of this proposal. A copy of this subsequent threshold determination will be available to the public upon request.
