We want to put a access drive from the county rd (Betts) to the upper part of the lots, or from 97 to the top of the lots. We will then pull power from Betts to the building sites. We are going to put a home on each of the 4 lots. There will be 1 well serving 2 homes each if the well produces enough water. If the well doesn't produce enough we will drill a well for each. We are in the process of acquiring water mitigation certificates from the Roan water bank now. They are available. We have gotten prices for power from PUD, and well drillers, and dirt work companies already.
