In regards to this project. KITTCOM recommends project have an assessment performed (and mitigation if needed implemented) for Emergency Responder Radio coverage as per [Washington Administrative Code \(WAC\) 51-54A-0510](#).

KITTCOM's radio signal modeling indicates the location does not have sufficient signal to support WAC requirements for Emergency Responder Radio Communications in the proposed project. Furthermore, due to facilities location, Chief Wiseman, Snoqualmie Pass Fire and Rescue (SPFR) confirmed significant event responses will require radio communications on SPFR primary, KITTCOM, and Puget Sound Emergency Radio Network (PSERN) two-way radio communication channels.
